6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 2:00 PM on 2080/01/11 at the office of Haripur Municipality, Haripur Sarlahi. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs 295000 which shall be valid for 30 days beyond the validity period of the bid.
