5. The bids will be opened in the presence of Bidders' representatives who choose to attend at 01-12-2022 12:30 at the office of Haripur Municipality Office. Bids must be valid for a period of 45 days after bid opening which shall be valid for 30 days beyond the validity period of the bid (i.e. [Refer Clause ITB 20.1]). If bidder wishes to submit the Cash Security, the cash should be deposited in Deposit Account No.[**0452050025949008**] at [NIC Asia , Haripur, Dharauti Khata] and submit the receipt of the deposited amount of cash along with the Sealed Quotation.
6. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission
