- 2. Minimum Work experience of similar size and nature: Construction of Two RCC 15 Bedded Hospital Construction Work of value Nrs. 14,00,00,000 (Without VAT) each within last 10 years.
- **3.** Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.

- 5. Bidder must submit their bid electronically by downloading the bidding documents for e- submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost of bidding document NRs. 10,000.00I- in the Project's Rajaswa (revenue) account as specified below . - 7. Electronic bids must be submitted to the office through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 12:00 on 2078-10-02. Bids received after this deadline will be rejected.
- 8. The bids will be opened in the presence of representatives who choose to attend at 2078-10-02 at 14:00 at the office of Haripur Municipality.
- 9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
- 10. Bids must be valid for a period of 120 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum of NRs.60,00,000.00/- (which shall be valid for 30 days beyond the validity period of the bid.
- **11.** Bidders can bid as a single contractor or in the form of Joint Venture of maximum of two contracting firms.
- 12. The employer reserves the right to accept or reject wholly or partially any or all bids without assigning any reason, what so over.
